

Key Intervention Areas Progress in FY 22-23

EMPLOYABILITY

Over the past decade, India has witnessed rapid growth, driven by the development of the new-age sectors. The rise in purchasing power has resulted in demand for a new level of quality of service. Employers frequently report a skill gap deficit in the candidates they hire, leading to a high demand of skilled manpower to address the rising requirements of the economy.

In this context, YES Foundation has undertaken skilling programs for underprivileged youth in service sector with an additional focus on soft skills and work readiness trainings. The program ensures that 30% of target beneficiaries are women and that at least 70% of the trainees receive gainful employment. Over 2,500 youth were trained through the project in FY22-23.



ENTREPRENEURSHIP

YES Foundation remains committed to maximizing fulfilment of Sustainable Development Goals (SDGs) and contribute to the national vision of an Atma Nirbhar Bharat. Our enhanced value proposition focuses on nurturing rural entrepreneurs and maximize their potential with an objective of strengthening rural economies.

Our project enhances income generation opportunities through farming extensions, agricultural inputs and promotion of handicrafts and handlooms. During the year, over 15,000 community members from rural Haryana, Odisha, Madhya Pradesh, Rajasthan, Assam and Uttar Pradesh were engaged through entrepreneurship development training and capacity building, market linkage and productivity enhancement.

In addition, over 5,000 farming households from rural Gujarat, Maharashtra, Madhya Pradesh and Rajasthan enhanced their income as they adopted climate resilient cropping practices, supported with soil conservation and water management technologies.

I got to know about YES Foundation's future skills program through an orientation session organized at our college. I completed my course in Java, which helped me in coding. I now have an improved skill set and I am grateful to the project for changing my life."

Uma Bai, our project beneficiary in Bagdar village of Rajasthan, belongs to a poor landless family with primary source of income from labor work. Her husband also works as a farm laborer but they face major livelihood insecurity during rainy season when no labor work is availabile in the village. Post our consultation, she expressed interest in starting a dairy business. She received training on dairy management through YES Foundation and is now able to earn a monthly income of seven thousand rupees by selling her buffalo milk to a cooperative. Uma happily *remarked,* "I i am grateful that I have a regular source of income and I don't have to stay away from home for long hours."

Environment Sustainability

We currently have two main projects under environment sustainability and in FY23-24, we will add a project on tree plantation as well.

Climate Modeling

YES Foundation continues to engage with IIT Delhi to develop and improvise climate-modeling methodology and contribute towards the formulation of an India-centric climate model.

In collaboration with the Department of Science & Technology (DST), Centre of Excellence (CoE) in Climate Modeling at IIT Delhi has co-authored knowledge report on 'Impact of Climate Change on Indian Economy'. YES Foundation continues to support research work undertaken to assess and substantiate the impact of climate change in Indian geography, specifically in terms of the changes in temperature and precipitation patterns.



YES! to Sustainable MSMEs in India

Micro, Small and Medium Enterprises (MSMEs) play a critical role in India's economic growth but the sector also accounts for a significant portion of India's total industrial pollution.

YES! to Sustainable MSMEs in India' is a program implemented by YES Foundation, which aims to support MSMEs for adopting best practices in Energy Efficiency.

Greening Highways

YES Foundation's project on 'Greening Highways' was concluded in March 2022. After having planted >40,000 plants and maintaining the same for a period of over five years, the project was successfully handed back to the NHAI. An endline assessment of the project was conducted by an external party and reported positive trends in soil health and air quality attributable to the plantation project. Chemical Resources, a Panchkula based MSME, manufactures medicines since 2003. As a part of our project, a walk-through energy audit was conducted and it was identified that the unit's power factor controlled panel was not working properly because of which extra energy was being consumed. The auditor also suggested for installation of variable frequency drive on large motors which were operating at variable loads and installation of automatic control of cooling tower fan, which would provide energy conservation during cold days. With just repairing the power factor controlled panel, the MSME unit saved roughly INR 1.42 lakh, conserving 18000 kWh of electricity in the process.

Grants and Accelerator


YES Foundation also concluded its 'Grants and Accelerator' project in March 2022. Under the project, social impact organizations that were selected were supported through capacity building sessions and a three-year scale-up grant. Capacity building sessions were delivered in compliance, governance, control, finance, risk and performance management. Through physical convening and remote engagement formats, the cohort was exposed to an ecosystem of sector peers, experts, social entrepreneurs and investors resulting in innovation, collaboration and increased efficiency and productivity.

In addition to the accelerator support, specific projects were identified to catalyze scale-up and growth of the selected organizations through milestone based grant spread over three years.

YES Foundation conducted an external impact assessment of the Grants and Accelerator Program. While excerpts from the findings are given below, the full report is available on the Foundation's website -




